On 1 January 2005, EU Regulation (EC) 178/2002 came into force throughout Europe to help guarantee food safety for consumers. Food businesses have a duty to provide traceability of raw materials and products through all stages of production, processing and distribution. Records must be kept for at least the shelf life of the product and information must be produced on demand to the competent authorities. There are no exemptions for small businesses and 'due diligence' is no defence against prosecution. Penalties for failing to comply are heavy.

- ◆ Instant forward and back traceability of all materials and batches

MCI Myrias minimises business risk in the event of a quality failure by allowing quick response to identify all affected items. The system allows all material lots in a batch to be quickly identified, and then all batches that use that material lot to be identified with production dates and depot locations.

- ◆ Covers all activities from Goods In to Despatch including delivery, storage, de-box, recipe formulation, mixing, pack filling, processing, order picking
- ◆ Controls label printers to print Lot and Batch labels to track raw materials, work in progress, production and despatch via dedicated barcode scanners.
- ◆ Links traceability data through comprehensive, easy-to-use reports using colour graphics and selectable data filters
- ◆ Every transaction includes time, date, lot numbers and operator identity for full accountability
- ◆ Collects data from scales, checkweighers, auto ID scanners, PLCs, Operator terminals, existing computer systems, test instruments etc.

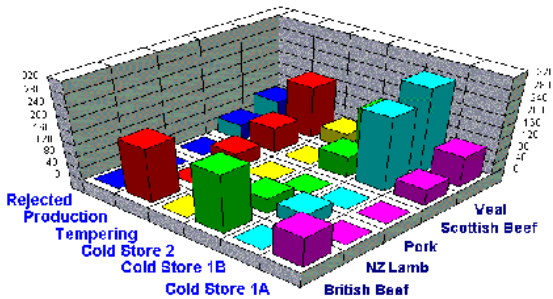
